#### C. CONSENT AGENDA:

- 1. CORRESPONDENCE FILED WITH THE COMMISSION Receive and File
  - a. Email received 02/04/17 regarding ""Cat Hoarding". This item was requested by the Commission to be moved from last month's meeting to this month's meeting.

Heard from Director Cullen who reports that there has been correspondence back and forth with the individual who wrote the email. He also reports that field services has gone to the residence in which there were 40 cats and field services has explained the TNR program.

- b. Email received 03/13/17 from Aaron Thames regarding "Kim Bennett and Kern County"
- c. Email received 03/16/17 from Chase Hunter regarding "Problems with Animal Control"
- d. Email received 03/16/17 from Chase Hunter regarding "CORRECTION Problems with Animal Control"

Heard from Jerri S. Bradley who reports that the issue is resolved. She reports that Chase Hunter is the individual who sold the dog owner the insurance spoken about in the correspondence. She refused to provide proof that the insurance she sold the dog owner actually covers dog bites and if so how much medical it covered. Jerri worked closely with the dog owner and his sister to obtain proof. Because of this incident, Commissioner Geary is modifying the typical order when insurance is ordered to specifically state certain requirements. She reports the dog owner complied with the order and picked up his dogs.

e. Email received 03/22/17 from Aaron Thames regarding "Kim Bennett and Kern County"

Heard from Director Cullen who states that when situations warrant the seizure of animals on a property and arrests can be made, that is in fact done by Animal Services. He states that there are some people who do just enough to be abiding by the law. He believes that Ms. Bennett is one of those people. Director Cullen states the most recent complaint stemmed from a social media post in which someone claimed there was no water running to Ms. Bennett's property and that the dogs were dying. Field services made a visit to the property and found that the claims were unfounded. Commissioner Madigan volunteered to meet with the complainants and make some proactive plans about how to solve the problem and reiterate what needs to be done and by whom. Director Cullen clarified that Mr. Thames used to be the owner of one of the dogs on Ms. Bennett's property and he willingly gave the dog to Ms. Bennett. Director Cullen states he would be more than happy to set up a meeting for Commissioner Madigan if that is her request. Director Cullen also clarified that there are other agencies now involved in the situation.

#### 1. VOLUNTEER UPDATE - Receive and File

Heard from Jeff George who reports the volunteer statistics for the month of March from the Director's report. He also speaks about the students and program at CSUB. He states that the students have completed 120 hours of time with the department. They learned all aspects of the shelter at a faster pace. They were allowed to spend a day with the Veterinarian and observe surgeries. Jeff also reports that National Volunteer Day is this Saturday from 10-2 and there is going to be lots going on at the shelter.

Heard from Blake Smith who reports on the data on the Spay/Neuter report. He reports that spending is on track and he isn't concerned with running out of funding at this point. Commissioner Madigan asked about a grant that was given to Animal Services Foster Coordinator. Director Cullen explains that it was a grant given to the department and Deanna went to San Francisco for 3 days and she brought back some valuable information. Commissioner Madigan also states that the Friends event was fun. Commissioner Madigan would like to further talk about it in the next meeting but she feels that a discussion needs to happen about re-defining what the Commission is doing and how they can be the go between for the Board and the department as was intended in the creation of the Commission. Lastly, Commissioner Madigan expresses her concerns with the way the Commission handled an item of correspondence in the March meeting that she was not present for. She feels very strongly that items of correspondence that are sent directly to the Commission be responded to by the Commission, especially in situations where the correspondence is emotionally charged.
