D. PUBLIC PRESENTATIONS:

Heard from Joan Peyton who suggested that the discussion regarding frequency of Commission meetings be revisited. Commissioner Madigan responded that she feels the Commission needs to be "reinvented" and that the Commission could be more involved on a more detailed basis. Commissioner Anderson suggest that the discussion be brought to January's agenda.

Heard from Liz Keogh who spoke about former Director of Animal Services, Denise Haynes and Ms. Haynes' retirement.

Heard from Stacey Jischke who would like to see the meetings continue monthly. She asked about taking a look at current legislation and how possibly coming up with new legislation might help solve some of the problems Animal Services currently faces. She also wanted to follow up with a request she sent to Director Cullen in October in regards to a place in Lamont she was concerned about. Director Cullen responded that there is an ongoing investigation regarding this situation. He encourages anyone who has ideas regarding ordinances to send those ideas to him. Commissioner Anderson also gives her input on code enforcement and ordinances.

Heard from Danny Spanks who wanted clarification on whether or not Animal Services has been to or located the property in which Ms. Jischke refers to. Director Cullen responds that the department has not located the property. Danny suggests that Animal Services have an educational meeting open to the public to help facilitate understanding of what Animal Services does on a daily basis. Commissioner Geary asks Director Cullen about the possibility of ride alongs to which Director Cullen responds that the department does allow ride alongs with Animal Control Officers and requests can be made through him. There is further discussion regarding ordinances and other processes that happen at Animal Services that are not necessarily publicized.

E. STAFF ANNOUNCEMENTS OR REPORTS:

DIRECTOR'S MONTHLY REPORT – Receive and file

Heard from Director Cullen who reports on the statistics on the Director's report. He reports that the Foster Coordinator was awarded a grant to go to Austin, TX and learn about their barn cat program. Director Cullen talks about the No Kill Coalition and it's purpose.

A unidentified member of the public asks Director Cullen if the department still has a program that goes to schools and educates school aged students. Danny and Director Cullen speak about the PAWS program which is not hosted by KCAS but that the department participates in. Director Cullen states that schools do contact the department requesting that the department come and do a presentation and he is more than happy to do that to contact him with the school's information. There was discussion about how to increase the number of live outcomes and the subject of spay/neuter is mentioned at which time Director Cullen talks about free vouchers for County residents to spay/neuter their pit bulls. There is further discussion on methods in which could be used to distribute information regarding spay/neuter. Commissioner Blackburn speaks briefly regarding the statistics in the Director's report.
