Heard from Michelle Vallejos who shared her concerns about the November ASC recordings, current status regarding activity on Silva St., trash bag dogs that had been dumped on Cottonwood and Hosking, and on the department's No Kill Kern County goal. There was brief discussion and Director Cullen addressed her concerns.

Heard from Darleen Voss who shared her concerns about stray dogs at Hart Park. There was brief discussion and Director Cullen responded to her concerns.

Heard from Stacey Jischke who stated she believes the Commission meetings should stay monthly. She also asked about how the public can participate in the revisions to ordinances that have recently been discussed.

Heard from Susan Richardson who shares her concerns about the publication of the Animal Services Commission meetings. She suggests the meetings be publicized in more places. She also shares her concerns about the stray dog problem in Kern County.

Heard from Christie Nolan also states that she would like to see the meetings remain monthly. She also states her concern with the department making owner surrendering animals more difficult in the future. She also gives a suggestion of making the meetings an event on Facebook to further help get the word out to the public.

E. STAFF ANNOUNCEMENTS OR REPORTS:

1. DIRECTOR'S MONTHLY REPORT - Receive and file

Heard from Director Cullen who further elaborates on his thoughts regarding owner surrendering dogs/managed intake. Director Cullen reports on the statistics on the Director's report and adds that the department's Foster Coordinator was awarded a grant to visit Austin, TX and learn about their barn cat program. Terri Kahn asks Director Cullen if the department adopts out dogs who have a bite history to which Director Cullen responds that dogs are not adopted out if there is a bite history however they may be released to a rescue. Michelle Vallejos shared her concerns and frustrations regarding the shelter's holiday hours. Director Cullen addresses her concerns and frustrations. Director Cullen briefly discusses the department's goal of No Kill by 2020.

Heard from Commissioner Taggart who spoke briefly in favor of managed intake.

Heard from Commissioner Blackburn who spoke about the statistics in the Director's report. He also asked if Deanna and/or Lisa could come and talk next month about their experience in Austin.

2. VOLUNTEER UPDATE - Receive and File

Heard from Jeff George who reported on the statistics and achievements for the calendar year 2017. Jeff highlighted that he hopes to have 3 projects completed by the Eagle Scouts. Commissioner Blackburn commends Jeff on the amount of volunteer hours he reported on.

Heard from Blake Smith who reports on the data on the Spay/Neuter report.

There are questions from unidentified members of the public about how they can have input in the proposed ordinance. There is brief discussion on how to go about doing so.
