REQUEST FOR ADMINISTRATIVE HEARING

Pursuant to Section 8.54.060 of the Kern County Code of Ordinance, any party who has been served with a Notice of Violation and Administrative Fine (Administrative Citation) may request an administrative hearing before a hearing officer to contest the imposition and/or the amount of the administrative fine. The request must be filed with the Department within fifteen (15) calendar days following service of the citation and must be accompanied by a payment equal to the full amount of the administrative fine.

Required Items for Administrative Hearing (Incomplete Applications will not be Accepted):				
1. Completed Request for Administrative Hearing application with original signature in blue or black ink.				
2. The request must be received by the Department within fifteen (15) calendar days following the date of service on the Notice of Violation and Administrative Fine (Administrative Citation) at the Kern County Animal Services Department or by mail.				
3. The grounds forming the basis for the hearing request.				
4. A deposit equal to the full amount of the administrative fine or a signed request for hardship waiver. (make checks payable to "Kern County Animal Services")

The officer's decision will be final and you will lose any right to contest the imposition of the administrative fine in a court law.
